


Alumni Relations Committee



IPL Auction 2022

ConCult, the Consulting, and Strategy Club of the Department of Financial Studies gave an entertaining twist to the regularly held cricket auctions. The Committee organized a Cricket Auction, where instead of the usual routine of judging teams on the basis of player ratings, which can become very subjective, teams were judged on the basis of what amount a particular player was bought at the mock auction and the amount he was actually bought at, in the real auction, thereby reducing all bias and making the judging criteria fair and transparent. With the mock auction being held just a week prior to the mega auction for IPL – 15, the interest and excitement increased manifold with seniors and juniors alike participating in the competition through 10 teams, each consisting of 5-8 participants. Each team was allotted 50 crores INR to acquire 11-13 players, including a maximum of 5 foreigners and satisfying the criteria of minimum

bowlers, batsmen, and all-rounders. The aim was to buy the players as cheap as possible as compared to the actual price at which they were sold at the real IPL auction. The team saving the maximum amount of money in the process of buying the players was to be declared the winner.





