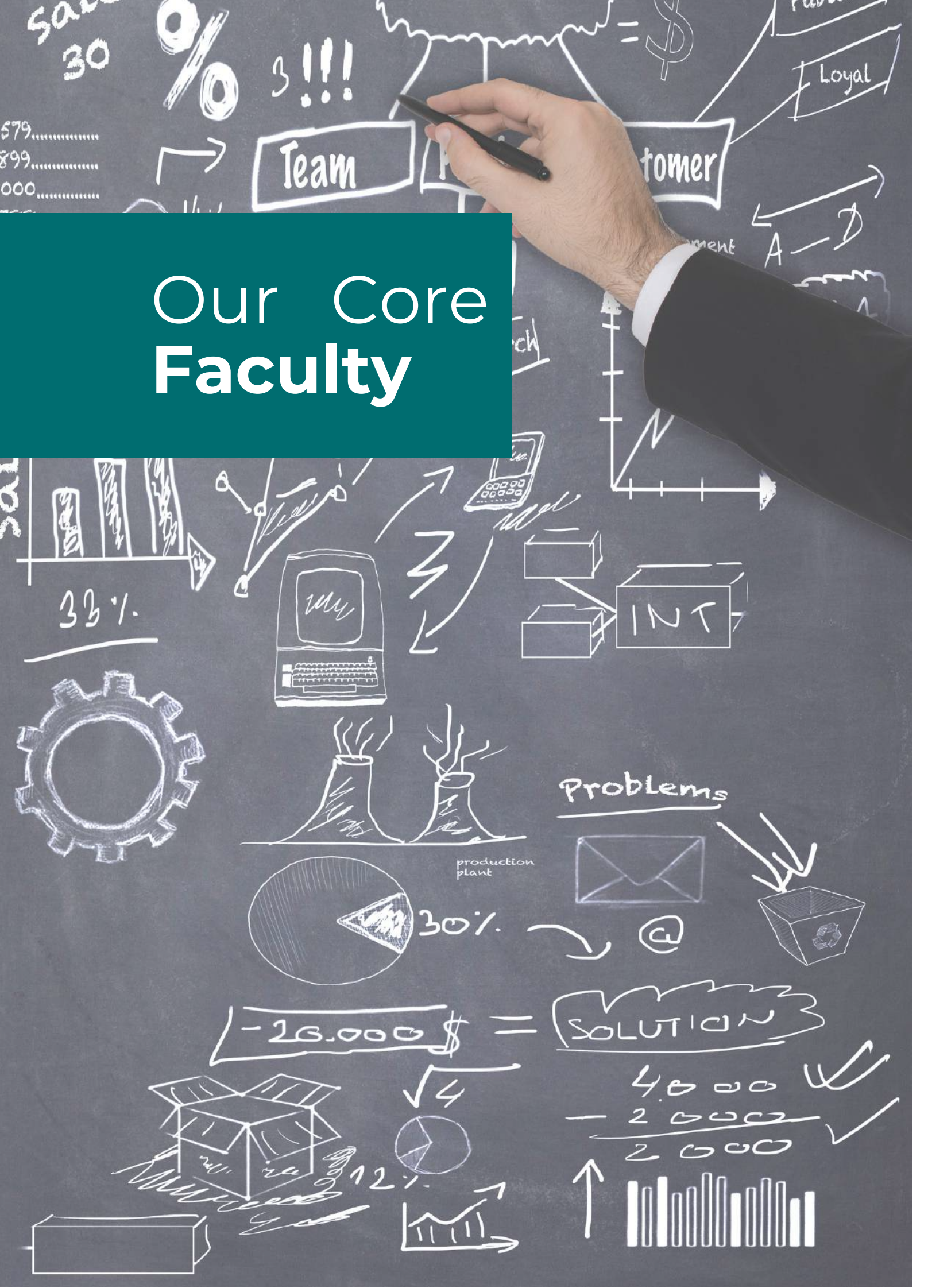

The discussion started with career progression and career advancement at work. Like, To improve the retention rate within a company and ensure that the most productive and innovative employees stay, there should be opportunities for the staff members to progress in their roles. Gen Z has higher expectations for the efficiency of work tasks and seeks to use the best quality technology. Homeownership in many countries is no longer as achievable for both Millennials and Gen Z. The inability to see their work reflected in temporal stability in their own lives results in these employees having much less loyalty to their employers. This also results in greater emphasis on leisure time and valuing life experiences such as travel and hobbies. These are the primary rewards for working available to these two cohorts of employees in society.

The theme for this session was "AI and HR." We learned that Artificial Intelligence has only recently been taken on board by Human Resources and only after being introduced into other fields. AI relieves HR of its repetitive, time-consuming tasks, meaning that HR staff, other teams, and managers can focus on more complex assignments. The AI approach to training involves a shift from acquiring business skills to customizing career paths. With the advent of learning analytics, training techniques are evolving. Data for tracking learning modes can be used to represent the way people learn and individualize suggestions for skill development.

In the coming decade, forward-thinking financial services firms that recognize the shift and foster digital equity and inclusive finance through innovation to drive sustainable growth will gain a competitive advantage and grow faster. As allocators of capital and risk underwriters, financial services firms have a prominent role in this transition to a more sustainable world that customers and regulators demand. Organizations should focus on inclusive finance, which aims to enhance fair access for individuals and businesses to a wide range of affordable financial products and services that meet customer needs and are delivered responsibly and sustainably.

## Knowledge Sessions

### CleanEnergy and Career opportunities in Finance in the respective sector

The session began with Mr. Alok giving a brief account of his journey, having worked in some of the biggest organisations not just in India but in the world. He told us why clean and renewable sources of energy are very important and needed, especially in today's world where energy demands have risen enormously and sustainable development is needed more than ever. Towards the end, there was a short Q&A where Mr. Alok emphasized the importance of India and how it will become the market for the world, and how Green Financing/ESG will evolve in the next 5-10 Years.

### Credit Risk Management in New Technologies

- » Mr. Akash Asthana – Vice President at Barclays

The session began with Mr. Akash giving a brief account of his journey, from being an Engineer to moving to the analytics field. He emphasized the edge one can have over others in the Risk Management Field by having proficiency in any statistical language. Towards the end, there were some more valuable insights on topics including the difficulty of assessing the climate risk, the role of the regulators and the use of Artificial Intelligence and Machine Learning in the said field. The session concluded with a detailed Q&A session.

### Understanding Business Finance: My Journey

The session began with Mr. Vibhor giving a brief account of his journey; having worked in companies like Wipro and Rivigo and moving to Myntra, he emphasized the edge one can have over others in the FP&A and Business Finance by having proficiency in Financial Data Skills and Reading.

Towards the end, there were some more valuable insights on topics including Inventory Management for E-Commerce, Revenue Generation and the overall scope of the E-commerce Industry and the Impact Finance can make on the same.

### Understanding Private Equity : My Journey

The session started with Prashant Sir sharing his philosophy and the importance of having a calm mind. He described how he sharpened his public speaking skills and what students can do to improve on the same.

### Badminton Tournament

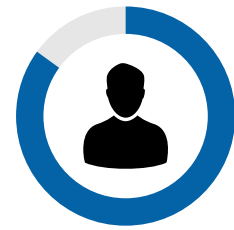
The badminton tournament that was organized in the college for men's singles, women's singles, and mixed doubles proved to be an enthralling event that left the audience spellbound.
